

# NATIONAL SOFTBALL FEDERATION OF AMERICA MINNESOTA SPORTS FEDERATION REGISTERED INVITATIONAL TOURNAMENT TEAM MEMBERSHIP/ROSTER FORM

## **GENERAL INFORMATION**

The Minnesota Sports Federation is the local association of the National Softball Federation in Minnesota. Teams that are not members through their local league and wish to participate in qualifiers or registered invitational tournaments registered by the NSF ◆ MSF or simply secure the team membership benefits must register for the \$15.00 fee. This one time fee provides eligibility for all qualifiers and registered tournament play throughout the entire summer. This membership does not qualify teams for MSF post season tournament play or national tournaments. To qualify for NSF ◆ MSF post season tournament play including national tournaments, Teams must emanate from leagues in which all the teams are NSF ◆ MSF members. Teams may also register on a per registered tournament basis for \$5.00 per weekend. These teams do not receive any publications.

### **MEMBERSHIP MATERIALS**

For the \$15.00 memberhip fee each team receives the services listed below:

- NSF ◆ MSF membership card
- 2) NSF MSF softball program guide, registered invitational tournament schedule, rulebook and scorebook
- 3) Access to www.msf1.org web site which features results, schedules and program summaries
- 4) Subscription to online publication, "Minnesota Amateur Sports Review"
- Eligibility to compete is NSF ◆ MSF sanctioned tournaments held in the state of Minnesota
- 6) Option to purchase low cost team liability and accident insurance
- 7) Services of the State Commissioner, State Umpire In Chief and District Commissioner/Umpires In Chief.
- 8) Membership in an organization striving to improve and promote the game of softball on a local, state and national level. The NSF MSF promotes the sport in your community and works for better facilities and programs.
- 9) Voting representation of the NSF ♦ MSF Board of Directors

#### **TEAM ROSTER/CLASSIFICATION**

The team roster and classification you list on the reverse side must identically match the team roster and classification previously submitted to the sports community your team competes in.

### TEAM MEMBERSHIP/ROSTER APPLICATION

Teams which are not members through their local leagues should register by submitting the \$15.00 fee and membership form directly to MSF offices well in advance of the tournament(s) they plan to participate in so the team membership materials can be forwarded. Proof of prior membership is your team membership card which you must be prepared to produce at the tournament site.
