# **Pinecone Central Park**

(Fields: Coborns, Miller, Joes Excavating, and Pinecone) 1105 Central Park Blvd, Sartell, MN 56377

From I-94:

Take I-94 West towards St. Cloud. Take exit 167B to merge onto MN-15 N toward St Cloud (7.4 miles.) Turn left onto Co Rd 1 (0.3 miles.) Turn left onto Heritage Dr (0.9 miles.) At the traffic circle, continue straight to stay on Heritage Dr (0.9 miles.) Turn right onto Pine Cone Rd S (1.7 miles.) Turn left onto Central Park Blvd. **From Hwy 10**:

Take MN Hwy 10. Slight right onto MN-15 S. Turn right onto Co Hwy 29(0.4 miles.) Continue onto 1st St NE(1.0 miles.) Continue onto 2nd St S(1.2 miles.) Turn right onto 57th Ave/Pine Cone Rd N. Continue to follow Pine Cone Rd N for 1.2 miles. Turn left onto Central Park Blvd.

Bob Cross Field 40 10<sup>th</sup> Avenue South, Sauk Rapids

# FROM HWY 15

- exit onto Benton Drive, traveling East
- Follow to 1<sup>st</sup> Street South and turn left, traveling north
- Bob Cross Field is located at 1<sup>st</sup> Street South and 10<sup>th</sup> Avenue South

# <u>FROM HWY 10</u>

- Exit onto Golden Spike Road and turn left, traveling west
- Follow to 6<sup>th</sup> Avenue N and turn left, traveling south
- Turn left onto 1<sup>st</sup> Street South
- Bob Cross Field is located at 1<sup>st</sup> Street South and 10<sup>th</sup> Avenue South
