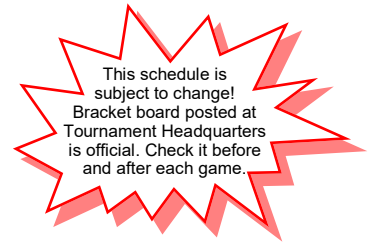

Specific Class Information

1. Class "CC/C" playing rule restrictions apply throughout pool and bracket play.

General Information

1. Top two teams in each pool will advance to "Class CC" Championship Series. Pool Third and 4th Place teams will qualify for "Class C" Championship Series play, but with the 5th place team in Pool A playing the 4th place team in Pool B to determine who will advance to Championship Series play, immediately following the conclusion of pool play.
2. Four team pools play three game set to 20 with 22 point cap. Five team pools play two game sets with each game to 25 with 27 point cap.
3. Championship series in each division will be played on best 2 of 3 basis with 27 point cap; the third game (if necessary) will be played to 15 points with 17 point cap.
4. If a forfeit occurs in pool play, the forfeiting team is disqualified and may not advance. All game results of the forfeiting team and their opponent(s) will be canceled.
5. If questions arise after reviewing the point system and the tie breaking/seeding procedures posted at the tournament site, please confer with the **Sports Federation Representative** at the tournament site for an explanation. **Do not wait until the last minute to resolve your questions.**
6. Team managers must point out any discrepancies in pool play results/seeding within 10 minutes after posting. After that time pool/seeding results become final unless a mistake can be corrected by MSF tournament management without substantial hardship or delay of the tournament. (Games will not be replayed). The above means teams should not consider posted results final until ten minutes after posting.

Awards

1. First and second place team plaques awarded in Class A, B and C along with individual plaques for the champion.
2. Third place plaques are only awarded in classes with four rounds of bracket play or more.
3. All class winners will receive a state championship banner.

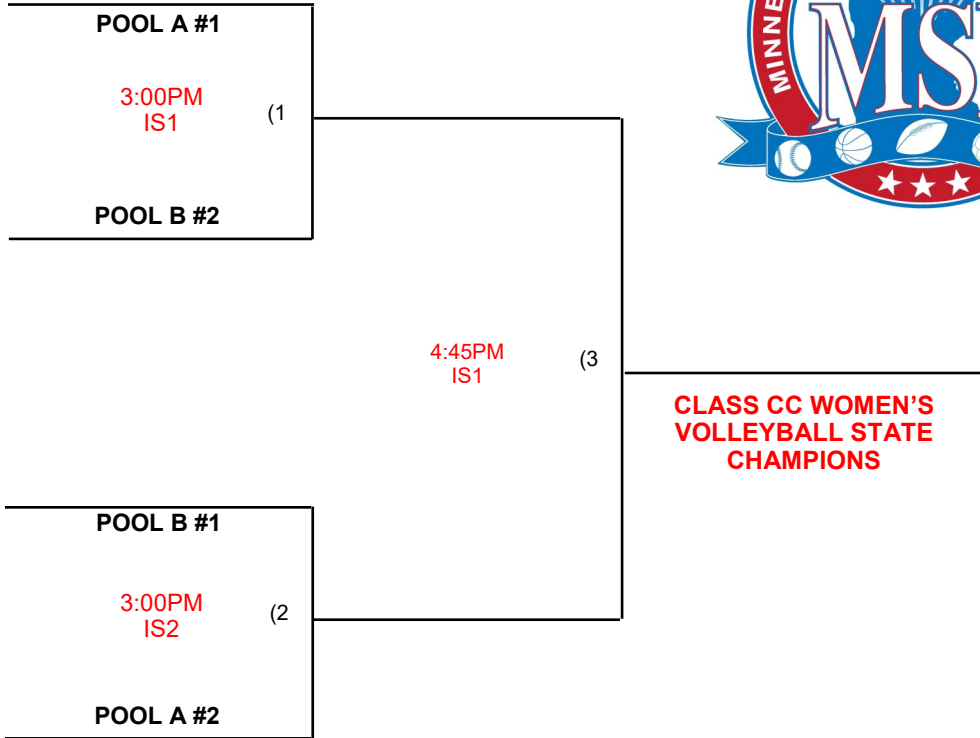

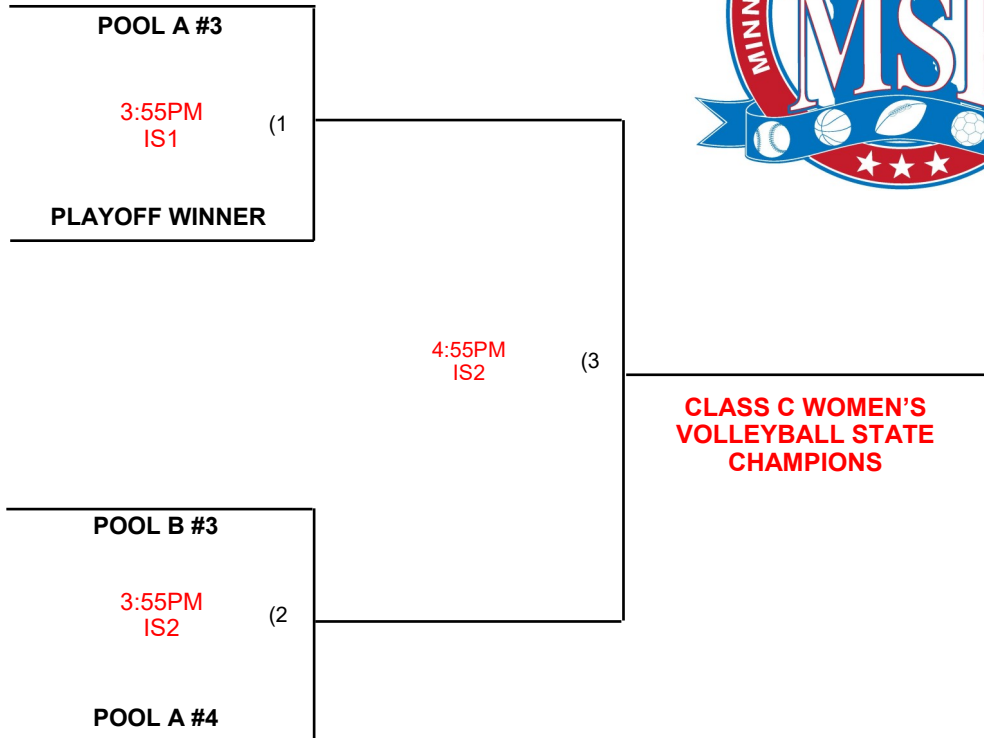
