TOURNAMENT INFORMATION

1. All pool play results count, unless there is a forfeit, in which case all results of the forfeiting team are canceled. If a forfeit occurs, the forfeiting team is disqualified and may not advance.
2. Pool play games will be two game sets to 15 with a 17 point cap.
3. Class A Team is declared State Champion after pool play. Class B Teams advance to Class B Championship Series. Class C Teams advance to Class C Championship Series.
4. If questions arise after reviewing the point system and tie breaking/seeding procedures posted at the tournament site, please confer with the **Sports Federation Representative** at the tournament headquarters for an explanation. **DO NOT WAIT UNTIL THE LAST MINUTES TO RESOLVE YOUR QUESTIONS.**
5. Team managers must point out and discrepancies in pool play results/seeding within 10 minutes after posting. After that time, all pool/seeding results become final unless a mistake can be corrected by MSF Tournament Management without substantial hardship or delay of tournament (games will not be replayed). The above means teams should not consider posted results final until ten minutes after posting.

AWARDS INFO

1. Teams receive \$15 for each two game set won in pool play for their post tournament party. Please see tournament site manager for payment upon completion of pool play.
2. Champions in each class receive individual plaques and team banner/photo op.

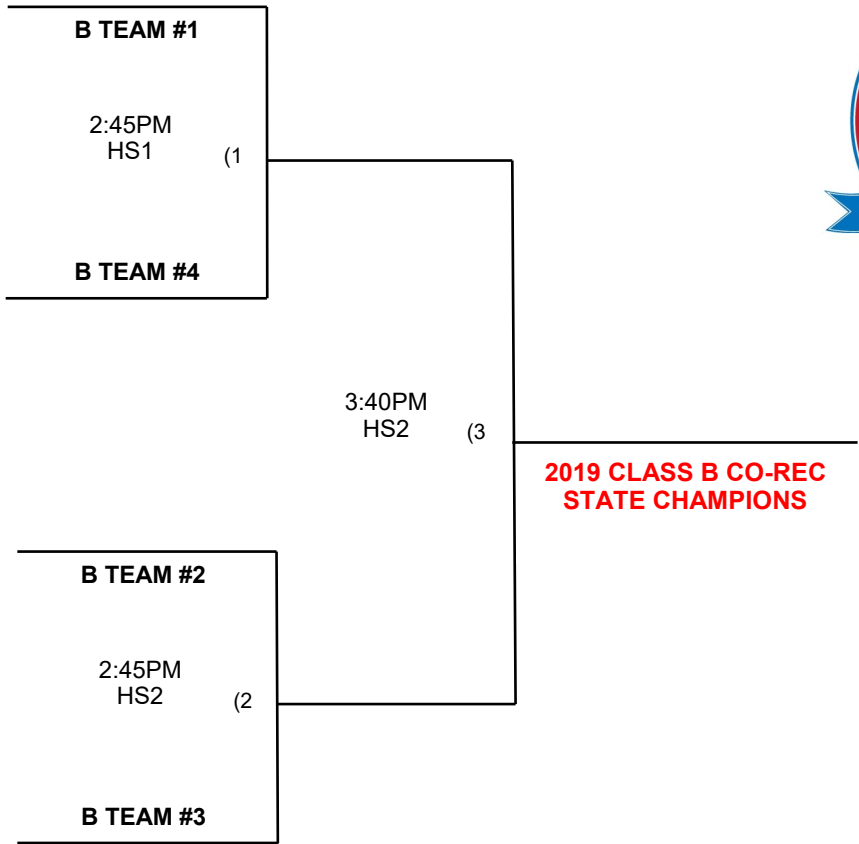

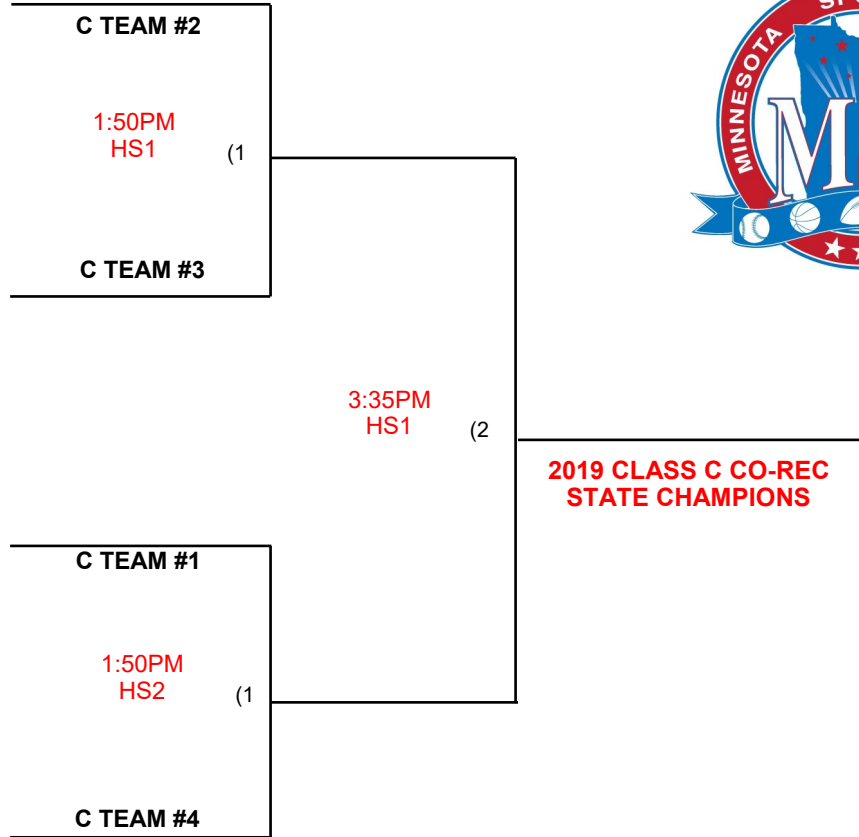
