### TOURNAMENT NOTES

- 1. The official tournament schedule is the bracket board posted at the tournament headquarters. Check in continually for changes. It is your responsibility to keep abreast of all changes affecting your team's play. It is the team's 100% responsibility to be in the right place at the right time.
- 2. The top three teams from each pool advance to the championship bracket. Pool 4th place does not advance.
- 3. Tie breaking procedures will be posted at the tournament site. If you have questions after reading the procedures, please ask the MSF manager for an explanation. **DO NOT WAIT UNTIL THE LAST MINUTE TO RESOLVE YOUR QUESTIONS!**
- 4. Should a forfeit occur within pool play at any time, all previous results of the forfeiting team shall be canceled. However, the forfeiting team may play the remainder of the schedule as an exhibition, provided their opponent agrees to play. Exhibition game scores will not be included when tallying the tiebreaker seeding/statistics. Forfeiting teams cannot advance to bracket play. Teams affected by a forfeit should report to the tournament manager immediately for further instructions.
