Dear NSF♦MSF Umpire,

Enclosed is your 2020 umpire membership application and miscellaneous information. The NSF♦MSF will once again offer an unequalled program at the lowest possible cost.

The MSF umpire membership fee is just \$55.00 (at least \$20 less than what other organizations charge) with a \$10.00 discount for those umpires who provide proof of their insurance for 2020 via NASO or the MSHSL when they submit their 2020 MSF membership form. No doubling up on your insurance costs!

You may complete the membership application and pay online at www.msfl.org and click on the umpire tab. Then, click on "2020 Umpire Membership" on the right side of the Umpires page. **ATTENDANCE AT A CLINIC IS REQUIRED IN 2020. PLEASE NOTE WEEKNIGHT CLINICS BEGIN AT 7:00PM (unless otherwise noted).**



The MSF believes in keeping fees for participation as low as possible, including for umpires. (Note: One of our competitors now charges as much as \$90.00 for umpire registration, double what MSF umpires with proof of insurance pay. Their uniforms are also more expensive). Since the formation of the MSF in 1982, we have saved member umpires and teams well over \$1,000,000 in membership and participation costs.

We have another busy season planned for you! Listed below are several highlights of the NSF♦MSF Softball umpire program:

1. Umpires working post-season, state or national events must wear heather gray slacks.
2. Umpires who attend a state or national umpire school and demonstrate proficiency will be given priority for post-season state and national tournaments.
3. **Umpires with three or more years of demonstrated state tournament officiating proficiency that are interested in serving as a state tournament UIC should contact their district or applicable state umpire-in-chief/district commissioner to express their interest in serving. Opportunities are available!**
4. When MSF games (league, registered invitational tournament, state or national, etc.) are offered, umpires registered MSF are asked to honor those requests prior to accepting assignments for non-MSF games.
5. Unlike some associations whose liability and accident insurance is only in force when working registered teams from the same association, NSF♦MSF softball umpire insurance is in affect for all softball games worked regardless of affiliation. Also, there is no deductible on the medical excess/accidental death policy unlike other associations.
6. **The Sports Federation offers an umpires' uniform program which features quality umpire equipment at low, low prices (see enclosed umpire equipment catalog and save on the best equipment available). You may also order online at www.nsfsoftball.org.**
7. Year circles are no longer provided. Your proof of membership is your membership bag tag.

We thank you for your past support of Federation programs and look forward to again counting you among the more than 400 Minnesota Umpires who are members of NSF♦MSF Softball, more than double our previous affiliation.

Best wishes for a successful season of umpiring and do not hesitate to call on the Umpire-in-Chief in your district if you need assistance. A directory is enclosed/attached.

c) **GRAY SLACKS** or navy blue shorts (Local communities and invitational tournament directors have the option to require full length slacks). Fastpitch and Modified Pitch umpires must wear full length slacks. Slowpitch umpires working a national qualifier or post season (state or nationals) must wear gray slacks. **Note:** When two umpires are employed, both must be in the identical uniform.

d) When shorts are worn, white knee high or mid calf tube socks with **two or three navy blue stripes** shall also be worn (extra long socks or mid-calf socks with two navy stripes are permitted). A black sock is also permitted when shorts are worn. Navy blue socks are permitted with gray slacks.

- navy blue or black umpire jacket (if a jacket is worn)
- black belt
- navy blue or gray ball bag
- black shoes (no white on shoes or no metal cleats)
- indicator and plate brush
- Sunglasses may be worn provided they are not mirrored, fluorescent, or other gaudy styles.

CONDUCT

An umpire membership shall be revoked for any of the following acts:

- Failure to wear the regulation uniform and properly display the MSF emblems when officiating in MSF registered tournaments or leagues. **Note:** Umpire can continue to wear the powder blue shirt with old logos until worn out as long as NSF cover up emblem is applied.
- Failure to honor game assignments.
- Failure to comply with the rules and regulations which govern member umpires.
- Committing an act which in the judgement of the MSF is deemed detrimental to fellow umpires and/or the state recreational sports program.

Umpires who fail to comply with the rules outlined in this section will have their membership revoked and be required to appear before the MSF Hearing and Protest Committee prior to being reinstated.

TOURNAMENT UMPIRES SELECTION PROCEDURES

GENERAL INFORMATION

Each year approximately 500 umpires are employed in MSF post-season tournaments. The official's association which services the host community during the regular season is utilized for at least 25 percent of the umpires, if available and qualified. The remaining assignments are distributed to qualified officials who have contacted the MSF State Umpires in Chief and expressed a desire to work. **Prospective tournament officials must possess a minimum of three years officiating experience and have exhibited their competency in regular season and registered invitational tournament play.** Umpires who attend a state or national umpire school during the current year and demonstrate proficiency will be given priority for post-season state and national tournament assignments.

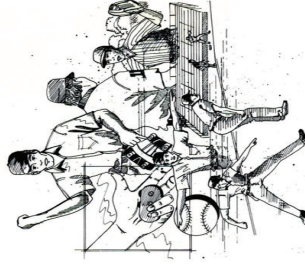
Officials who are interested in working tournaments in their district should contact their respective District Umpire in Chief. Officials interested in state or national tournaments should contact the State Umpire in Chief. Written correspondence with references and experience should be sent no later than April 1.

NOTE: Members of officials associations located in communities where a MSF post-season tournament is scheduled need not contact the State or District Umpire in Chief, but must inform their assignment secretary of their desire to work.

When MSF games (league, registered tournament, state, national, etc.) are offered, umpires registered MSF are asked to honor those requests prior to accepting assignments for non-MSF games. If an MSF umpire works a non-MSF assignment when an MSF assignment has been offered they are subject to lower MSF assignment priority in the future for league, registered tournament, regional, national competition, etc.

Services and Regulations

UMPIRE MEMBERSHIP INFORMATION

REGISTRATION

All umpires who officiate league games or registered invitational or post-season tournaments held in Minnesota which are registered by the MSF must be registered with the MSF.

TO OFFICIALLY REGISTER AS A MSF UMPIRE AN INDIVIDUAL MUST MEET THE FOLLOWING TWO REQUIREMENTS:

- Send the membership application and the \$55.00 application fee to MSF Offices no later than 10 days prior to the clinic you plan to attend, or register and pay online at www.msfl.org by clicking on the Umpire Tab, then click on the "Umpire Membership" tab in the right hand column.
 - If you neglect to mail your application a minimum of 10 days prior to the clinic you plan to attend, then retain it and bring it with a check or money order to the clinic you attend. This method is not recommended because it may necessitate waiting in a line to register.
 - If the application is mailed to MSF Offices after you have already attended a clinic then you must include \$6.00 for postage and handling along with your clinic attendance slip.
 - If you already possess NASO or MN State High School league supplemental liability and excess medical insurance, you may deduct \$10.00 from the \$55 fee. Proof of insurance, (documentation) must be provided at the time of registration.
 - Renewal umpires who apply and/or attend a clinic after May 1 will be assessed a \$10.00 late application penalty.
- Attend at least one certification clinic listed on the enclosed schedule. **(ATTENDANCE WILL BE TAKEN.)**

To expedite the registration process, avoid paying the \$6.00 postage and handling fee and assure you will be able to pick up your packet of materials at the clinic you attend; please submit the registration application online or via US Mail a minimum of ten days prior to the clinic you plan to attend. You will receive via return mail a post card verifying receipt of your application. This post card must be presented at the conclusion of the clinic you attend. A packet of materials will be provided in exchange for the attendance slip. If you attend ten days in advance of the clinic and do not receive verification of the clinic or you will be required to mail in your attendance slip with \$6.00 for postage/handling in order to receive your packet. **IF YOU FORGET TO BRING YOUR POST CARD TO THE CLINIC YOU WILL NOT RECEIVE A PACKET AND WILL BE REQUIRED TO MAIL THE POST CARD TO MSF OFFICES ALONG WITH A \$6.00 FEE FOR POSTAGE AND HANDLING.**

IMPORTANT NOTE

Certification clinic sites are chosen in a manner that attempts to provide optimum geographical coverage. However, we realize there are some local associations which would prefer to have a clinic in their city, or solely for their association. Please contact an Umpire in Chief if your organization is interested in this service.

ONCE THE TWO REGISTRATION REQUIREMENTS STATED ABOVE ARE MET, THE UMPIRE RECEIVES THE SERVICES DESIGNATED BELOW:

SERVICES

- A \$1,000,000 general liability insurance policy which covers the umpire for bodily injury or property damage to others arising out of all operations in connection with softball umpire activities. (This is not liquor liability insurance.)
- A \$10,000 secondary health insurance policy with no deductible which covers accidental injury arising out of softball activities of the umpire.
- If a team possesses MSF team liability or accident insurance it will be in force during the games you officiate.
- MSF Rule Book
- MSF Membership Bag Tag
- Certification Clinic
- Eligibility to umpire games in which MSF member teams compete throughout the entire state of Minnesota.

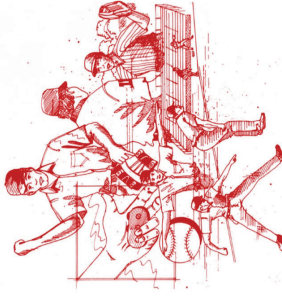

RULES AND REGULATIONS

- THE ABOVE SERVICES ONLY APPLY WHILE OFFICIATING MSF MEMBER TEAMS, LEAGUES OR SANCTIONED TOURNAMENTS. TEAMS MUST BE MSF MEMBERS AND THE UMPIRE MUST BE IN REGULATION UNIFORM.
- All umpires shall be MSF registered and in regulation uniform (see below) to officiate MSF registered teams/leagues or in MSF registered invitational or post-season tournaments.
- ALL UMPIRES SHALL CARRY OR BE PREPARED TO IMMEDIATELY PRODUCE THEIR CURRENT MSF MEMBERSHIP CARD AND MINNESOTA DRIVER'S LICENSE UPON THE REQUEST OF THE STATE COMMISSIONER, DISTRICT COMMISSIONER, STATE UMPIRE IN CHIEF, DISTRICT UMPIRE IN CHIEF, REGISTERED INVITATIONAL TOURNAMENT DIRECTOR OR LOCAL LEAGUE DIRECTOR.



UNIFORM

- The MSF letters must be worn on the umpire cap and the MSF ♦♦ MSF logo must be worn on the powder blue umpire shirt.
- Uniforms are available through the Sports Federation Office. The regulation uniform consists of:
 - powder blue style micro-mesh polo shirt with white and navy trim and MSF ♦♦ MSF logo embroidered on left chest is required. If a local officials association emblem is worn, it shall be sewn on the right sleeve of the shirt. No other emblems may be worn.
 - official blue umpire cap with white and blue or red outlined, MSF letters embroidered across the front — only available through Sports Federation Offices. Caps are required for both men and women. (Visors are not legal)
