Lowell "Pete" Jordan

The promotion and enhancement of the game of softball in Clearwater County was largely due to the efforts and dedication of Pete Jordan.

In the early to mid 1970's, Bagley had a very small group of fast pitch softball teams that Pete played and umped weekly at the local Frog Pond.

In 1975 Pete teamed up with Pat Hanlon to share umping duties so Bagley could start their own slow pitch softball league. The men's league played 3 nights a week and a few years later, a women's league was added 1 night a week. Pete was at the softball diamond 3, and eventually 4 nights a week, umping a double header for 15 years plus.

If there were any big tournaments in the area (many of which were held in the neighboring town of Clearbrook), Pete was there umping from round one all the way through the championship game under the lights. It was not uncommon for Pete to ump 12-13 games in a day and sometimes turn around and do it again the following day.

Pete umped in 12 District and 5 State Tournaments during his tenure. This number could have been much higher but that was never his goal as an umpire. He passed on state tournaments for personal reasons...one of which was to coach his daughter's team, the Clearbrook Merchants, to a Class C State Championship in 1980.

Pete recruited and mentored many younger (his daughter being one of them) umpires during his tenure in which he umpired well over 1,000 games. His biggest attribute to the game was how he taught, advocated for, and expected good sportsmanship and respectful play from all of the teams he umped.

Bagley received a grant from the Minnesota Twins to refurbish and bring back to life the "Frog Pond" softball diamond that was a community gathering spot for so many years. Pete was asked to ump the inaugural first game of the "Return to the Pond." Pete umped all 5 games that day AT THE AGE OF 80!!
